- I. Call to Order- 7:05 p.m.
- II. Grievances- The Executive Committee met with the District 5 Grievance Committee before the meeting. There were two grievances received from an incident at a gambling location of two Board Members and a Committee Member discussing the gambling manager and other topics. The Grievance Committee stated that those named in the grievances did violate Minnesota Hockey Code of Conduct violation. The Board discussed the information and the two Board Members took full ownership for their actions. The Board discussed that this is an opportunity to update our code of conduct and how to move forward with grievances in our policies and procedures.
 - The recommendation of the Board of Directors is that the President and VP of Operations are on probation for all the time that they serve on the Board per violation of MN Code of Conduct. A motion was made by Jack Rowan and Adam Frost to approve the statement. Motion approved.

III. Gambling Manager Candidate Review

- Megan McChesney recused herself from the discussion and abstained from the vote so there is not a Conflict of Interest as one of the candidates is her brother.
 Megan Esterberg reached out to Nate Allen, Association Attorney, to confirm that this would need to happen.
- The Board discussed the two candidates, as well as the need for looking at the structure of gambling in the future and look at hiring an assistant.
- A motion was made by Chad Vitzthum and seconded by Jack Rowan to approve
 Tyler Stone as Gambling Manager. Motion approved.
- A motion was made by Adam Frost and seconded by Jack Rowan to pay Tyler Stone a base salary of \$62,500, a stipend of \$250 a month, with no bonus for the first 90 days, a 2.5% bonus for 91-180 days and 3% bonus for 181-365 days and a \$5,000 bonus for a five star rating from the Minnesota Gambling Control Board. Motion approved.
