- II. Association Attorney Nate Allen, Esq. Gries, Lenhardt, Allen PLLP

Nate Allen discussed the following with the Board:
    - Composition & Structure

    - Fiduciary Duties of Care, Loyalty & Obedience
      - STMAYHA is still a corporation which is bound by state and governing documents; benefits of being a 501c3 in Minnesota to have extra protection under non-profit code, which includes not being responsible personally. If the 501c3 status then that protection goes away.
      - Be active, it's important that you participate. If you don't vote it's considered a "yes" vote; this is your one chance to object. If the Board voted and you disagree, you should not "air dirty laundry" in public. Allegiance does not mean you have to vote "yes".
      - Conflict of interest is most detrimental with business transactions; may abstain on voting if there is a conflict of interest. Need to make sure we are all following policies and procedures.
      - It is a Board Member's fiduciary duty to get outside help when it's needed.
      - Nate Allen suggested completing the Bylaws and then designating a committee to come back to the Board with updated policies and procedures as we should be following our policies and procedures. Outside counsel can review afterwards. Also the Bylaws should be reviewed annually.
