MN Hockey's 2025-26 Locker Room Monitoring Policy

MN Hockey acknowledges the Locker Room Monitoring Policy as established by USA Hockey. Monitors must be the same gender as the players and undergo background screening by MH to serve in this capacity.

No team or player shall be allowed to enter a locker room prior to a scheduled event until a locker room monitor is present <u>in</u> the locker room and such monitor shall remain <u>in</u> the locker room until the last player leaves the locker room unless coaches are present. When coaches are present in the locker room, they may serve as locker room monitors.

It can't be a 1:1 situation in the locker room where there is only 1 adult and 1 player. For example, when a player is ejected from a game there must be at least two (2) adults consisting either of locker room monitors or coaches in the locker room with the suspended player.

Alleged violations of these rules shall cause a mandatory hearing to be held in accordance with MN Hockey Bylaw Article 6. If warranted, a suspension penalty may be levied upon the head coach or person in charge of the team if the head coach is not present. The penalty for violations of this rule shall be \$500 for the first offense, \$1,000 for the second offense, and \$2,500 for the third offense. These fines are the responsibility of the offending team and shall be paid to the applicable district.



Parent/Legal Guardian Registration Requirements

<u>EVERY</u> parent/legal guardian is required to register on Crossbar at: <u>https://www.stmayha.org/program/volunteer-registration/24820</u> The following items are required:

- 1. USA Hockey Number (https://www.usahockey.com).
- 2. Background Check (https://www.usahockey.com/backgroundscreen).
 - USA Hockey Background check must be completed every 2 years.
- 3. SafeSport Training (https://www.usahockey.com/safesporttraining).
 - Must complete each season.
 - STMAYHA will receive confirmation of SafeSport completion through USA Hockey.

Volunteer Policy

☐ This policy is in effect from May 1, 2025, through April 30, 2026.
☐ Families must complete 12 hours/per player. There is not a separation in required how for gambling volunteer shifts and hockey volunteer shifts.
\Box Families have the option to buyout their volunteer hours at \$1,200 per player.
☐ Failure to meet requirements by the end of the policy year will result in \$1,200 charges per player to the credit card on file this is considered all or nothing.
☐ Every family is expected to volunteer for team specific activities that supports their player's team. Volunteering for such activities does <u>not</u> apply to each family's volunte requirements as outlined above.
Examples: Running the clock, scorekeeping, running the penalty box during player's scrimmages/games, locker room monitor duties, making door signs and other team specific activities.
No Show Policy* - If you are signed up for a volunteer shift (gambling or regular) and complete that shift, for whatever reason, you will be charged: 1st offense - \$100** 2nd offense - \$250** 3rd offense - full volunteer requirement amount of \$1,200**
*Canceling a volunteer shift within 48 hours will result in no-show fees. **Fee charged to the card on file in Crossbar.

Minnesota Hockey's Waiver Requirement

Per MN Hockey's current Participation Policy, players must participate with the association whose boundaries incorporate the player's residence. If a player lives outside of an association's boundaries but open-enrolls in a school within that association's boundaries, a School Attendance Waiver can be granted at their first year of travel hockey.

- If you player played on a school waiver for STMAYHA during the 2023-2024 season you do not need to do anything you are grandfathered in.
- If your player lives outside the STMA School District and is either homeschooled or is enrolled in STMA Online, your player must play for their association of residence.
- If you fall outside of the possibility of a school waiver please reach out to Adam Frost @ <u>president@stmayh.org</u> to have a discussion about a discretionary waiver.



Parent/Legal Guardian Code of Conduct

Because our children learn from our example, we need to exemplify the highest level of sportsmanship by supporting all players, coaches, team managers, referees, and parents.

No inappropriate yelling at or actions towards players, coaches, officials, arena personnel, volunteers, parents or spectators. Parents/legal guardians who are hostile or otherwise act inappropriately in any arena or via email, phone call, text message, written/typed letter, or any social media avenue may be subject to disciplinary action by the STMAYHA Executive Board.

Observe the 24-hour rule: No parent/legal guardian, or relative of any STMAYHA player, in a fit of frustration/anger over a player's ice time/position, coaches' play of a player, and/or team status per STMAYHA's tryout policy will contact the coach, level coordinator, or any other member of the STMAYHA Board of Directors within 24 hours. This includes face to face, email, phone call, text message, written/typed letter, or any social media avenue.

This Policy is adapted from USA Hockey's "Zero Tolerance" Parent Code of Conduct – Please be advised that non-compliance will result in sanctioned consequences.


