- IV. Gambling Report- RaeLynn Cook
 - Expenses:

 - Villa Bar & Grill New Safe, came in slightly higher than what was approved last month; total cost \$1,020.05.
 - BK Tap Haus Thursday Meat Raffle starting 1/19/23; starting cash bank of \$200.00.
 - o General Fund Donation of: \$60,000.00.
 - Updates/Other Items:
 - Fund Loss from 11/2020 (storage shed break-in).
 - Additional restitution checks reissued, received and applied to the outstanding balance. \$129.84 received to date.
 - Being submitted to the Gambling Control Board for recommended approval at their 1/17/23 meeting.
 - Supplier increase coming mid-January; 7-11% on all paper products (pull tabs, paddlewheel tickets, bingo paper, tip boards, etc.).
 - Received notification from the auditing firm that we have used for the last two years that they will no longer be servicing charitable gambling organizations. Will have quotes available next month from new firms to consider.
 - Working with Tournament Director, Christine Shidla, to finalize partner and event advertising, as well as pin location and pick up for the RiverHawks Rumble - January 20-22, 2023.

 - Volunteer learning sessions will be held during 10UA practices the week of the RiverHawks Rumble.
 - Preview Cup brought in \$590 profit from vendors.

VI. Board Reports -

- D5 Representative Aaron Levin
 - Squirt/10U year end tournaments are the weekend of 3/10.
 - No full ice mite games will be allowed next year.
 - District playoff schedules should be posted by mid-January.
 - D5 acknowledges that they aren't following the 120 games rule, when they scheduled 160 last weekend. Smigs and D5 to settle on the number.
 - New "Futures Development Program" was created by MN Hockey. This will be ran by Thomas Johnson, details are on the D5 site (Open to all kids 2010-2011 level, starts end of March goes through May, please look at D5 Website for more information. The idea is to keep kids in MNHockey and USAHockey rather than AAA. Kristin VanHeel to put out a communication to all 2010-2011 kids since it is for all kids. It is first come, first serve and must be played where the skater lives- D5 will be run out of Buffalo.
 - D5 is looking to have more team declaration consistency next year This
 is coming full circle from conversations that began 5-8 years ago. AA

 come at the next couple of D5 meetings. They are also looking to shut

Ashlie LeGrande addressed the board about the KnightHawk. She is questioning whether the band will work in the venue and is looking for an email vote on Friday to possibly change the venue; giving her time to check back into the costs of the Rider issues. The band is huge and they want to play for STMAYHA regardless of the venue. Megan Esterberg said the rider was sent to Brian and due to his multiple family issues, he does not seem to be able to meet the obligations of the Riders, so the cost will be on us. Board asks for a Friday deadline for this budget. MN Wild, MN Timberwolves, pharmaceutical company and other huge donors all set per Ashlie LeGrande. Committee hasn't had its first meeting, so there are other potential revenue streams. Jack Rowan asked for a ticket sales goal - we need to make sure we need to say sales tax included if we hit the threshold.
