Officer Reports:

President Report- Travis St John- 2nd sheet of ice- made progress. Total cost 15million, hopefully a little less. We are sticking to our limit of 10 mil and the city needs to come up with in kind donations for 1.8mil. The city is contributing 3.2million. Not require us to put the max of seating, parking for 200 seats in the beginning. Samson is working to update numbers with engineers. Life expectancy for the current ice rink is 5 years. Travis has told them that we should not be responsible for that update. HTG is working on updating drawings that will give us a new fly through and pictures for the new facility. Contract for the architect work- 200K most that we spend going forward with the contract. Making a motion for the signing of the new agreement for HTG-\$568,000 to be paid with donor money and not savings. Brad Cannon makes the motion to accept the contract and for it to be shared with the group, Kera seconds motion for the contract. Motion passed and was approved unanimously.

Finance report- 5 to 7 players that are not a travel team and they were invited to play in the home tournaments and shared in the credits but not the expenses. We need a guideline in place for this in the future. These players should pay a pro-rated amount moving forward. **Refer to the policy League and teams- I starred in the section.**When using a club debit card, please make sure to provide a club tax exempt form. HS state- all players got a credit to their accounts- seniors credit will just sit there unless they have siblings to roll over to. 12 seniors this year, 2 of them have younger siblings. 10 seniors that will still have a credit. Current policy is that the credits would roll into our scholarship account.

\$1,297.93 total credits for the seniors. What do we do with the larger credits? Travis thinks we just need to cut checks back to these families.

Executive Director Report- Jami Warner- Worked with Austin on summer skills- ways to get more kids involved. Each week reducing the rates by \$20. Goalie sessions-Austin kept 3 of the 6. Working with Angela on the accounts, trying to get everything to match. Kera, Jami and Angela are reaching out to families. Worked with Chad on the Mile High Mites program. The city provides 10 grants to children that want to attend the mile high mites program. Angela and Jami are still working with Mike on the coaching credits. Working with Billie for the ref in chief next season. New person with the ref'r system and they are working with them to get this going. Sports engine bought crossbar. Getting things ready for registration. We will open up registration July 11th this year, 2025- 2026.

Coaching Committee- Mike Barager- He did not want to open an application until after the deadline. Travis wants to move forward with the current applicants and follow up with them individually

The local association may choose based on the talent level of the teams to declare 2 A teams, 2 B teams or an A and a B team. It is recommended each team have twelve (12) unique players (players may be counted on only one roster for the purposes of team calculation).

Intent of Proposal

\$1,000 dollars is nothing for a team of 20 hockey players. That is \$50 dollars per player, the gas to travel would be more than that. The planning and preparation of the teams hosting games far exceeds \$1,000. The economic impact removed from the community is tens of thousands of dollars in hotels and business to local proprietors. We are allowing teams to simply pay rather than travel. I also believe the team should be ineligible for the state tournament EVEN if they pay the fine. The travel is reciprocal every year and the team you are playing normally traveled to your community the year prior.

Intent of Proposal

I have had a significant amount of people complain to me that players were given Northern Plains camp positions and they were not even in attendance at the development camp. I was in attendance at Girls camp and witnessed this myself. Girls camp in particular, multiple girls were sent to Northern Plains that had no reason for not being at camp other than they had other activities they were attending. To be considered for Northern Plains a player should be at the development camp or a lot of people are starting to say why should they even come to development camp and hope for a spot at Northern Plains if it's just given away to someone who didn't even come. There can be NO variation from this or the Team WY development program will even further see low numbers in attendance.

The local association may choose based on based on the talent level of the teams to declare 2 A teams, 2 B teams, or an A and a B team.

Specific Wording of Proposal

At the 10u, 12u, and 14u age divisions, the local association may choose based on the talent level of the teams to declare 2 A teams, 2 B teams, or an A and a B team. For the HS level, the first team declared by an association shall compete in the Varsity Division. Where an association is able to field a second team, that team shall be declared a JV, or B team. JV teams shall play a majority of their regular season schedule in the JV division, playing at least four games against other JV teams. Where an organization fields only one HS level team, that team shall play a majority of their schedule against other Varsity division teams, and shall compete at the Varsity State Tournament.

Intent of Proposal

The intent of this rule is to, where possible, match younger lower level teams with each other, allowing a more closely matched level of play to encourage development at the JV level. I. The final standings for the 2024-2025 season, the five true JV teams, being the five teams that were the organizations second HS team, were also the five lowest in the standings. These players will benefit more by playing each other

than from playing teams that would have been competitive at the Varsity level. There is also a large gap physically and intellectually between an 18 year old senior, playing full contact hockey against a 15 year old freshman. In many larger population areas, this is solved by having a 16u division, in addition to an 18u or Varsity HS division. While this is not avoidable in an association that fields only one HS team, this rule would reduce those mismatches where possible. The younger players will benefit from a more consistent and closer level of competition, reducing blowout scores and keeping younger players more engaged and less likely to be injured by older players, and retaining more of those younger players who may otherwise become discouraged and stop playing.

In short, the first HS level team in any organization shall declare as Varsity. Where an organization has enough players to declare two HS rosters, the first team shall declare Varsity, and that organization's second team shall declare JV. JV teams shall play each other for a majority of their regular season schedule. For the purposes of the State Tournament, only true JV teams (declared as an organization's second HS team) shall play in the JV division. For organizations rostering only one HS team, that team shall compete in the Varsity State Tournament.

- a. Rule changes may be ratified every three years at the Annual WAHA meeting. The next rules meeting will be April 2022.
- b. All changes are to be sent to the President of every local program and all governing bodies, including all WAHL participants, fourteen (14) days prior to the date of the annual meeting.
- c. Ratified changes shall be effective September 1st of the following hockey season.
- d. All changes shall be dated and signed by the WAHA Secretary and the WAHL Commissioner.
- e. Original signed WAHL documentation will be held by the WAHA Secretary.

Specific Wording of Proposal

V. Rules and Regulations Changes

- a. Establishment of Ad Hoc Rule Committee
- i. The WAHL Commissioner shall establish an ad hoc rule committee (the "Committee") to evaluate and propose rule changes as needed to ensure safety, fairness, and growth of hockey within the WAHL. The Committee may propose rule changes to the WAHA/WAHL Board at any board meeting, provided the Committee determines a change is appropriate based on safety, fairness, growth, or the mission of WAHA and WAHL. Except for rule changes proposed by the Committee no rule changes shall be allowed or proposed except for during the triennial rule change process as set forth in subsection (b).
- ii. The Committee shall consist of at least five individuals and up to seven individuals composed of the following:
- (a) At least two local association presidents;
- (b) At least two WAHL age directors; and
- (c) At least one other WAHL officer (e.g. Commissioner, Vice Commissioner, Ref-in-Chief, etc).

iii. The Committee shall only be required to meet to discuss interim rule changes when needed, and meetings may be in person or virtual.

b. Triennial Rule Changes

- i. Any local association through its president, WAHL officers, and WAHL age directors may propose rule changes during the triennial rule change process that occurs every three years at the WAHA/WAHL annual meeting.
- ii. Proposed rule changes during the triennial rule change process shall be submitted at least 14 days prior to the date of the annual meeting.
- iii. Any rule changes adopted through the triennial rule change process shall be effective September 1 of the following hockey season.

Intent of Proposal

Purpose: The purpose of this rule is to establish a formal process whereby rules can be changed outside of the triennial rule change process. It requires the Commissioner to establish a committee that can review rules and propose changes during the interim. Any interim rules would still need to be approved by the entire WAHL/WAHA board.

The WAHL Commissioner will communicate the deadline and the State Bid form will be available on www.wyohockey.com far in advance of the deadline.

Specific Wording of Proposal

Delete IV. Section m and the last two sentences of section 5 and create a new section for State Tournament Location Rotation Policy

- A. The WAHL Commission and each age director shall compose a committee that determines the location of state tournaments (the "WAHL Tournament Committee").
- B. On or before September 15, 2025, each local association shall submit a bid to the WAHL Tournament Committee that includes the following information:
- i. Whether it desires to host a state tournament in 2026 and
- ii. Whether it desires to host state tournaments in future years and to be considered part of a rotation
- C. At least 30 days prior to the September 15, 2025 deadline, the WAHL Tournament Committee shall provide a list of factors it will consider in determining host locations and rotation.
- D. Following submission of bids, the WAHL Tournament Committee shall establish a rotating schedule for state tournament locations, prioritizing geographic diversity across Wyoming to balance travel demands for participating teams while ensuring fairness to those associations willing to host tournaments.

E. The WAHL Tournament Committee shall have discretion to determine the rotation and in so doing shall not be required to treat the proposed or interested sites equally, but instead shall determine the rotation based on factors it deems important.

F. The WAHL Tournament Committee and age directors shall announce the dates of the state tournaments no later than the annual meeting the year prior to the state tournament.

G. Modifications to rotation: After the rotation is set by the WAHL Tournament Committee, the rotation shall only be modified in the following circumstances:

i. If any location determines it is unable to host its scheduled state tournament it shall notify the WAHL Tournament Committee on or before September 15 of the year before the tournament and the WAHL Tournament Committee shall seek bids from local associations to host that state tournament.

ii. If a location withdraws from two state tournaments within a five year period the WAHL Tournament Committee shall consider whether to remove the site location from the rotation.

iii. If a site location is not part of the rotation and desires to be added in the future it shall submit a bid to the WAHL Tournament Committee and the WAHL Tournament Committee may modify the rotation, provided the modification occurs at least one year prior to scheduled state tournaments.

iv. If the WAHL Tournament Committee determines the rotation for any tournament to change, the WAHL Tournament Committee may modify the rotation as long as (a) the local associations impacted receive notice and the ability to provide feedback on the proposed modification, and (b) any modification occurs at least one year prior to the scheduled state tournaments.

Intent of Proposal

The purpose of this rule is to set a rotation for statement tournaments. It is my understanding that one of the primary factors considered in setting state tournaments is where the tournament was in prior years. If this is the case, then establishing a set rotation will eliminate unnecessary work. A rotation also ensures each host location has sufficient time to plan for the tournament. Rather than set a rotation in the rule itself (a task that all local associations could likely debate for hours without any agreement), this rule allows the committee an opportunity to determine locations for 2026 state and then build a rotation based off that. The intent of this rule is to be fair to all associations, not equal, if certain locations deserve a state tournament every year, while other locations deserve to only host two out of three years etc., then this rule allows for that determination to be made. While I am new to WAHA/WAHL, the current system is not transparent, creates unnecessary work, and leaves everyone hustling to prepare for tournaments. Room blocks, sponsors, and virtually everything could be prepared well in advance and all of our tournaments would improve. Please note that current structure of the rules references state tournaments in a few locations and that is also confusing, this proposes creating a new section related to state tournaments.

WAHL Scheduling Proposal for A-Level

Divisions (5-Team Brackets)

Objective: To reduce excessive opponent repetition, streamline scheduling, and improve the overall experience for players and families by transitioning from the current model to a consolidated "Festival Weekend & quot; format.

Current WAHL Scheduling Structure (5-Team Divisions)

- Total Games: 20 WAHL games per team

- Division Size: 5 teams

Game Breakdown:

- Each team plays two (2) opponents six times:
- One team: 4 at home, 2 away
- One team: 2 at home, 4 away
- The remaining two (2) opponents are played four times:
- 2 at home, 2 away

Travel & Home Weekends:

- 5 Home Weekends:
- 4 weekends with standard 2-game series
- 1 weekend hosting a 4-game series
- Travel Weekends:
- 4 weekends with standard 2-game series
- 1 weekend with a 4-game series on the road

Result:

- Every team travels 5 times per season
- Each team plays two opponents six times, which leads to matchup fatigue and limits variety
- Scheduling is handled through individual association coordination, which can be inconsistent and difficult

Proposed Festival Weekend Model

- Total Games: 16 WAHL games per team

- Weekend Format:

- 5 total festival weekends
- Each weekend hosted by a different association
- All 5 teams gather at one location
- 1 team plays 4 games; the other 4 teams play 3 per weekend (the 4 games only happen once per team per season)

Hosting Structure:

- Each of the 5 associations hosts one festival per season
- Hosting rotates every time

Travel Efficiency:

• Each team travels 4 times per season and hosts 1 time

Why the Festival Model Makes Sense

- Reduces Redundancy: No more playing the same team six times
- Streamlines Scheduling: Eliminates back-and-forth negotiations and makes planning easier for schedulers and families
- Improves the Player Experience: Festival weekends have energy, visibility, and event-style feel

- Travel Smart: Hosting teams get a break with only four road trips per season
- Fair and Predictable: Everyone hosts once per year—equity is built in over time

Recommendation

We propose piloting the Festival Weekend format for the 2025-2026 season in all WAHL A-level divisions that have 4-6 teams (e.g., 12U A, 14U A, and High School A). After the season, WAHL can evaluate the results, solicit feedback, and decide on wider adoption.

*Modification could be test running with 14U & High School A-level vs entire association to start.

This isn't just a change in scheduling—it's an investment in a better, more balanced experience for everyone involved. Let's raise the bar for what WAHL hockey can look like.

Current Wording

The 18U and 19U Girls State Tournament Weekends will include an All-State Hockey Team selection process. Each All-State team will consist of 6 forwards, 4 defense, and 2 goaltenders. Local associations will provide All-State nominees to the respective age director 2 weeks prior to the state tournament. The nominees will include 3 forwards, 2 defense and 1 goaltender. An electronic ballot (link) will be created including all nominees, their season stats and coaches notes will be provided to the head coach of each team. Each Coach Will Vote For 3 forwards, 2 defense and one goaltender, not on the coaches team. Results will be sent to the AD and Commissioner. The top vote getters will fill the All-State team. In case of a tie, PPG will be used for skaters, and Save % will be used for goaltenders. If all openings are not filled, the top PPG nominee(s) in said division will fill skater spots and top Save % in said division will fill goaltender spots. The awards will be purchased by WAHL.

Specific Wording of Proposal

All-State Awards & Dividual League Honors

Proposed Rule Update - Wyoming Amateur Hockey League (WAHL)

I. Selection Committee Members

The following individuals will serve as the official voting body for All-State Nominations and the League's Top Individual Awards:

- WAHL Player Development Director
- WAHL Referee-in-Chief
- WAHL High School Age Director
- WAHA President
- WAHL Commissioner

Conflict of Interest Clause:

Any committee member with a direct conflict of interest (e.g., a child or immediate relative being nominated for an award) will be recused from voting on that specific award. Their position will be removed from the committee for that vote only, ensuring an impartial process.

II. Individual League Awards (Combined A & Divisions)

These league-wide honors recognize outstanding individual performance across both divisions. The awards will be selected by the voting committee listed above.

1. Goaltender of the Year

Eligibility Criteria:

- Must have played in at least 50% of scheduled league games.
- Primary statistical evaluation includes:
 - Lowest Goals Against Average (GAA)
 - Highest Save Percentage (SV%)
 - Number of Shutouts

Tie-Breaker Protocol:

In cases of statistical ties or close comparisons, Goals Against Average will be the primary deciding metric over Save Percentage.

2. Defenseman of the Year

Eligibility Criteria:

- Most points scored among defensemen.
- Players cannot have more penalty minutes than points scored.

Disciplinary Consideration:

- Misconduct and Unsportsmanlike Conduct penalties will be reviewed and could be exempted at the discretion of the committee.
- Repeated misconduct or unsportsmanlike penalties will negatively impact candidacy.

3. Forward of the Year

Eligibility Criteria:

- Most points scored among forwards.
- Same disciplinary review standards apply as for defensemen:

- More penalty minutes than points are generally disqualifying unless due to a single misconduct penalty that may be exempted by the committee.
- Repeating offenses will weigh negatively in the selection process.

4. Mr. Wyoming

Overview:

 Awarded to the top overall player in the Wyoming Amateur Hockey League. Open only to Senior-class athletes. This honor may be awarded to a forward, defenseman, or goaltender.

Nomination Process:

- Three players will be nominated by the committee.
- Nominations may represent any position (e.g., 3 forwards, 2 defensemen + 1 goalie, etc.).

Eligibility Criteria:

- Goaltenders must meet the 50% minimum games played requirement.
- All players will be evaluated on:
 - o Overall skill and leadership
 - Points or stats (position dependent)
 - Penalty discipline (same review criteria as above)
 - Academic standing (GPA will be considered)
 - Letter of Recommendation from coach or administrator

III. All-State Teams - 1st and 2nd Team Recognition

These teams recognize high performance at each position and are selected per division (A or B) unless divisions are combined.

Selection Process:

Head Coaches from each team will submit nominations:

- 3 Forwards
- 2 Defensemen
- 1 Goaltender

Team Composition:

- Each All-State Team will consist of:
 - 3 Forwards
 - o 2 Defensemen
 - o 1 Goaltender

Division-Based Award Structure:

- If 4 or fewer teams exist in a division (A or B), only a 1st Team All-State will be named.
- If 5 or more teams exist in a division, both 1st Team and 2nd Team All-State selections will be awarded.
- If the A and B Divisions are merged into a single division, both 1st and 2nd All-State teams will be named for the combined division.

Eligibility Notes:

Players from Freshman through Senior year are eligible.

Age or class standing will not influence voting.

^{**}The selection committee will review nominations and vote to determine All-State teams.

The awards will be purchased by WAHL.

Intent of Proposal

Remove the bias of coaches nominating <u>AND</u> voting. Increase the scrutiny to be quality young men by a panel of a committee, and not just stat based.

Proposals to WAHA Annual Guide to bring Wyoming policies and practices in alignment with USA Hockey. Proposed wording is in red and if to be omitted, strikethrough.

Proposal 1: NO

Rationale: Add statement recognizing Team Wyoming tryouts to be completed before considering other tryout options.

TEAM WYOMING

Team Tryouts: Except for Team Wyoming teams, no Team shall conduct tryouts or player selection until after May 1 of each year.

Proposal II. YES

Rationale: Volunteers must complete Safe Sport and Background screening; eliminate reference to out of town teams, add member before programs as this is USAH Annual Guide terminology. Add item 6 to formalize process.

Player, Coach, Volunteer and Team Registration Requirements

USA Hockey and WAHA require all players, coaches, and volunteers to be properly registered before the player, coach or volunteer is eligible to participate with on-ice activities, including practices before any games are played including tournament games, exhibition games with out-of-town teams and WAHL games. Teams, coaches, and local member programs who violate these mandates are subject to suspensions, fines and removal from all WAHA and USA Hockey sanctioned activities.

6. Submit a transfer request for approval when moving to Wyoming affirming player is in good standing with previous affiliate and member association.

Proposal III: YES

Rationale: confirm yellow highlighted section is most current language – referred to WAHA CIC. Update language in item 5., as Safe Sport no longer issues a certificate of completion, and the individual receives an email from USAH indicating completion.

1. All USA Hockey coaches will possess a USA Hockey Coaching Education Program card with valid certification stickers (if certification was received prior to September 1, 2011), or a printout from the USA Hockey online certification list (if certification was received after September 1, 2011).

5. Complete the USAH SafeSport training and submit a copy of the SafeSport certificate confirmation of completion email issued by USAH.

Proposal IV: Team Managers YES

Rational: Remove unnecessary language at end of opening sentence. Update Safe Sport language as stated in Proposal Ill., above. Add language as a designated Locker Room Monitor is a required roster designee.

A Team Manager must complete the requirements and submit the following documents to the local program Registrar prior to any program activity. where the Team Manager has any personal contact with any underage (under 18) players:

- 2. Complete the USAH SafeSport training and submit a copy of the SafeSport certificate confirmation of completion email issued by USAH.
 - 4. The designated Locker Room Monitor (s).

Proposal V: Local Registrars **YES**

Rationale: Add language as WAHA and all member program boards must have an approved USAH roster; set consistent timelines for roster submissions.

Local Registrars

Rosters shall be submitted for approval at least two weeks prior to first game.

Board Rosters

WAHA and each Member Program affiliate will submit to the Affiliate Registrar a Board Roster. Each board member must complete online registration with USAH as a Volunteer if they are not already a player, coach or manager. At the beginning of the season, each local registrar shall create a "team" through USAH Portal. The team type selected is "Board" and members are listed as "staff". All Board members must pass background screening and Safe Sport. The following positions shall be included: President, Vice President, Secretary, Treasurer (Secretary/Treasurer), Safe Sport Rep, CIC, RIC. All others shall be listed as Director. Board rosters must be completed by Sept.15 of each year.

Local associations are encouraged to submit a volunteer roster when they have designated persons to serve as scorekeepers, box, etc.

Local rosters may be submitted for approval once the Board roster has been approved and will not be approved beforehand.

Proposal VI: Local Tournaments YES

Rationale: update language to include USAH approved in Tournament definition

• Definition of a Tournament: Ice hockey competition, other than normally scheduled league or exhibition games, where three or more legally registered and USAH approved teams compete within a specified time frame for the purpose of declaring a champion.

Proposal VII: NO

Rationale: Clarify language pertaining to roster classifications. **USAH language requires the association rostering members to be in the majority**. Proposed language provides clarity for the protection of the member program as well as providing opportunity for play. Many member associations have policies that do not permit their players to participate on more than one team at any level or out of state.

It is at the discretion of each member program if they chose to collect a fee for non-member players. There is a recommendation to consider this as each program assumes responsibility for all players on roster.

Effective 8/1/25 and past teams will not be grandfathered. Every effort is made to support existing teams.

Rostering of Teams

In accordance with USA Hockey requirements for affiliates, the Wyoming Amateur Hockey Association ("WAHA") requires all team rosters to be approved by the Affiliate Registrar. Teams may be rostered in accordance with the following procedures.

1. Team Wyoming

Team Wyoming teams are rostered as independent teams directly by the Affiliate Registrar and are not affiliated with a local association.

- a. Team Wyoming teams are the only teams recognized by WAHA as National Tournament Bound teams.
- b. No other teams shall be considered NTB.

2. Member Program Teams.

- a. Each Member Program that competes in WAHL shall submit the roster for each team to the local and then Affiliate Registrar for approval, in accordance with the rules for the league.
- b. WAHL Teams shall include WAHL in the team's name. This roster may also service as a travel roster for the member program.
- c. Teams competing in the Colorado Recreational Hockey League are recognized as recreational teams and must comply with CHRL rules and policies. Teams are rostered as House/Rec.

3. Invitational Tournament Teams

- a. Member Programs may roster teams for travel or invitational tournament play. The roster should be composed of players from the local Member Program.
- b. In keeping with USAH roster member language, the majority of the players must be from the local member program submitting the roster.
 - c. Should the team wish to roster a player approved on a different team roster, the local manager/coach must:
 - i.) obtain and submit written permission from the player's current association and affirmation that the player is in good standing and thereby released for play utilizing WAHA template no less than 3 weeks before tournament date.
 - ii.) affirm there are no policy conflicts for player that will negatively impact their play and return to home member association.
- iii.) submit that dates for requested tournament as roster will be time limited. All three items must be satisfied before the roster will be approved.

4. Independent teams

If a local member program either refuses to approve an invitational tournament team or if such a team does not have a majority of players from one local member program, then such team may petition the WAHA Executive Committee for approval, subject to the following requirements.

- a. The majority of the players must reside in the state of Wyoming in accordance with current USAH rules.
- b. WAHA may elect to impose a fee up to \$1000 for the team
- c. The team must comply will the criteria outlined in 3. b. I, ii, and iii) above.
- d. WAHA Executive Committee maintains the right to consider and approve such teams, provide oversight, and roster an independent team. WAHA will convey approval of the

- team to the State Registrar, and the State Registrar may still ensure all USAH rostering rules are satisfied and impose additional requirements.
- e. The proposer assumes responsibility for assuring that no player will be in violation of his/her home/state rules and policies for playing outside of their Affiliate and association.
- f. Team must be approved each year and roster limited to specified tournaments.
