STICK & PUCK PARTICIPATION REQUIREMENTS

- Full gear is required for all on-ice participants.
- No refunds for not having required gear.
- Must be 5 years or older.
- A certified ice hockey helmet WITH MASK is required for any skater 5–18.
- Parents are responsible to check skater equipment if under 18 years of age.

PARTICIPATION AGREEMENT, RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND ASSUMPTION OF RISK

BY SIGNING THIS DOCUMENT YOU MAY BE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE

ASSUMPTION OF RISK: I understand and acknowledge that ice skating, ice hockey, and related activities involve certain inherent risks, dangers, and hazards, including but not limited to: collisions, falls, contact with other participants, puck or equipment injuries, equipment failure, ice conditions, and other hazards, which can result in serious personal injury or death. I knowingly and freely accept and fully assume personal responsibility for all such risks, both known and unknown, and the possibility of personal injury, death, property damage, or loss resulting from participation.

RELEASE AND WAIVER OF CLAIMS: In consideration of being allowed to participate in Stick & Puck or related on-ice activities at the NOCO Ice Center, I hereby agree, for myself and on behalf of my minor child and our respective heirs, assigns, and personal representatives, as follows:

- 1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the NOCO Ice Center, its employees, agents, volunteers, and sponsors.
- 2. TO RELEASE FROM LIABILITY and TO HOLD HARMLESS the NOCO Ice Center from any and all liability for any loss, damage, injury, or expense that I may suffer, whether caused by the negligence of NOCO Ice Center, its staff, or otherwise.
- 3. TO INDEMNIFY the NOCO Ice Center from any and all third-party claims resulting from my actions during participation.
- 4. I agree that the Participant will follow all posted and verbal instructions, safety guidelines, and conduct rules set forth by NOCO Ice Center and its staff. I understand that violation of safety rules or staff instruction may result in removal from the ice without refund.

ENTIRE AGREEMENT: I acknowledge that I am 18 years of age or older, have read and understood this agreement, and am aware that by signing I am waiving certain legal rights. If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect. This Agreement shall be governed by and interpreted in accordance with the laws of the State of Colorado.

IF PARTICIPANT IS A MINOR (UNDER AGE 18): I, as parent or legal guardian, agree to the above on behalf of the minor and consent to their participation. I also agree to indemnify and hold harmless the NOCO Ice Center for any claims resulting from the minor's participation.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
